

Principles and method of protection of the processing personal data by the Controller Grand hotel Permon, s.r.o.

Grand hotel Permon, s.r.o. respects your right to privacy in world of the internet and when using our website and in electronic communication with us. We have introduced the necessary measures to store all of your personal information that you provide safely as described below.

This data protection policy explains how data is processed by Grand hotel Permon, s.r.o., Pribylina 1486, 032 42 Pribylina, ID: 44130651, as part of using the Internet and other alternative electronic communications for direct marketing.

Grand hotel Permon, s.r.o. is responsible for processing your personal data in accordance with the legislation in force for the Slovak Republic. The terms “we”, “us”, “our” “Grand hotel Permon, s.r.o.” and “Empora Hotels Group” used on this site refer to Grand hotel Permon, s.r.o. and its affiliates according to the context. “You” refers to the person accessing and/or using our website. Grand hotel Permon, s.r.o. processes only personal data to which the data subject concerned has explicitly given their consent with reference to the provisions of Art. 6(1)(a) of the Regulation of the European Parliament and EU Council no. 2016/679 on the protection of individuals with regard to the processing of personal data, “GDPR” and the provisions of Section 13(1)(a) of Act no. 18/2018 on the protection of personal data ..., or which are necessary to provide (and improve) our service to you. The Controller only processes personal data listed in the individual provisions of Act 18/2018 on the Protection of Personal Data and the amendment of certain acts, i.e. “the processed data consists only of gender, title, forenames, surname, date of birth, address, email and telephone number of the data subject without the possibility of adding further personal data to it and its use is intended solely for the needs of the Controller in correspondence with the data subject and for the recording of this data; if the business of the Controller is direct marketing, the personal data may be provided to another Controller which has the same line of business solely for the purpose of direct marketing. and if the data subject has not withdrawn its consent under Section 23(2)(b) of Act. 18/2018 on the protection of personal data and the amendment of certain acts.

We want to assure you that Grand hotel Permon, s.r.o. will take all necessary measures to maintain security and safety of the data that you provide, including in particular:

1. Adopt all necessary measures to preserve the confidentiality and security of your personal information.
2. Access to your personal information will only be for authorized persons of our company, which in turn are provided only within the scope of the Act.
3. All authorized employees of our company who have access to your personal data must comply with the Data protection Policy of Grand hotel Permon, s.r.o.
4. To ensure the protection of your personal data, our company maintains a secure IT environment and has taken the necessary measures to prevent leaking of personal data received and processed.
5. Your personal data will be processed only for the purposes for which it was provided to the company. It will be used to provide, support and obtain feedback on the level of our services and to prevent the violation of security, laws or our contractual terms.
6. Our company will never share your personal information with any third-party company that

intends to use it for direct marketing purposes. unless you give explicit consent.

7. The Company may share your personal information with other companies within the Empora Hotels group, where for that purpose you have provided express consent to the sharing of your personal information with third parties, but only under strictly limited circumstances, enabled by the cited act:

- We may disclose your personal data to third parties (such as providers with the same type of business as the Controller and the administrator of internet services) to help manage this web site on the basis of a contract for the processing of personal data.
- Your personal data can also be provided to public authorities and judicial authorities if: required by applicable law; or in our good faith belief such an action is necessary to comply with legal procedures; when responding to legal claims or litigation; or to protect the rights of Empora Hotels or its customers and the public.
- In some limited cases, we may provide your personal information to potential acquirers of the Empora Hotels company concerned, provided that we have legally ensured the confidentiality and security of this data and that in disclosing such personal data, our company complies with applicable laws and that a contract for the processing of personal data has been concluded.
- Our company will not use your personal information (including your e-mail address) for direct or indirect communications unless you give us your express consent and have not withdrawn this consent.

8. Our company stores and keeps personal data provided to us via the website, in its databases, for as long as it is reasonably necessary in view of our need to provide you with answers to your questions or to resolve problems, provide improved and new services and comply with the relevant statutory regulations. This means that your personal data will be retained for a reasonable period after you stop using the services of our company or using this website. After this period, your personal information will be deleted from all systems Grand hotel Permon, s.r.o., or Empora Hotels Group, or it will be deleted after you withdraw your consent, by giving written notification to Grand hotel Permon, s.r.o., 032 42 Pribylina 1486, or by e-mail to: **hotelpermon@hotelpermon.sk**

9. We have the right to delete the personal information that you provide to us at any time.
